## What is the Global Environment Facility?

- It is a fund US\$ 2.8 billion for projects over the period 2007-2010
- It focuses on developing countries and transition economies
- It funds projects and programmes that protect the global environment
- It is the funding mechanism for several Multilateral Environment Agreements (Climate Change, Biological Diversity, etc.)



## Funds available by focal areas

Focal Area	US\$ million
Biodiversity	950
Climate Change	950
International Waters	335
Ozone	40
POPs	282
Land Degradation	282
TOTAL	2,839



## How funds are allocated to different countries

- Total funds for a Focal Area are divided among the countries based on
  - potential to deliver global environmental benefits and
  - > governance
- There are country and group allocations
- Countries in consultation with the GEF Secretariat decide what national projects to undertake and finance, and which GEF implementing agencies should assist and manage the projects



## **GEF and Co-Funding**

- The GEF ALWAYS requires co-funding for its projects
  - minimum 1:1, but the more, the better
  - co-funding can be "in-kind" as well as cash contributions to the project.
  - cash contributions CAN STAY WITH the project partners
- This makes critical to mobilize additional funds, secure partnerships with key project stakeholders and the active participation of targeted beneficiaries



## The Climate Change Focal Area

**Objective:** Reduce global emissions of greenhouse gases (CO<sub>2</sub>, etc.)

## **Strategic Programs**

- Energy-Efficient Buildings
- Energy Efficiency in Industry
- Renewable Energy (for on-grid)
- Modern Energy from Sustainable Biomass
- Sustainable Transportation

Climate Change Mitigation

Adaptation Pilot → Climate Change Adaptation

## Reducing Greenhouse Gas Emissions through Improved Energy Efficiency in the Industrial Sector in Moldova

- MENR identified Energy Efficiency in Industry as priority for the GEF Climate Change Focal Area and requested the assistance of UNIDO to develop a project
- UNIDO and MENR started in 2007 to work together to develop a GEF project proposal aimed to promote and support enhanced energy efficiency in Moldova industry

## Reducing Greenhouse Gas Emissions through Improved Energy Efficiency in the Industrial Sector in Moldova

- Activities carried out
  - Industrial data and information collection
  - Consultations with stakeholders, prospective partners and targeted beneficiaries (Govt. institutions, industrial associations, manufacturing enterprises, local experts and NGOs, and other international organizations)
  - Industrial energy efficiency project concept prepared and submitted to the GEF Secretariat
  - Project concept approved in Dec 2008 for further development
